

Our Costs are Growing

Our church is an amazing building which is used every day by a wide range of people, charities and organisations. But it costs over £1000 every day to run. In recent years we have been good stewards of our resources, and have income from car parking and the rental of the crypts, the hall and our parish rooms. But a sizeable proportion of our income has to come from congregational giving, and this is where you can help.

How can you Help?

You can help in two ways. Firstly, please bring your friends and neighbours to join us! The best way to increase our congregational giving is to build up our congregation. Secondly, please increase the amount of money you give to support the church if you possibly can. Our giving should be generous, whether we have a little or a lot. And if you do have a lot, remember there is no limit to the amount you can give!

Regular Giving or Cash in the Collection?

Please include your giving to St Peter's in your budget. Plan your giving, feel happy with what you decide, and give it regularly. The very best way to give to St Peter's, for you and for us, is through a monthly Standing Order paid directly from your bank. There is a form here for you to set this up easily, or to change an existing order. You can still put money in the collection at any time, or use our envelope scheme if you prefer, but monthly giving from your bank is best.

Gift Aid - Boost your Giving

Every £1 that you give to St Peter's is worth £1.25 if it is given through the Gift Aid Scheme, which allows us to reclaim from the government the tax already paid on the money you give. To enable us to reclaim tax and increase the value of your gift, please complete the Gift Aid form here.



Boost Your Giving - Gift Aid Declaration

Every £1 that you give to St Peter's is worth £1.25 if it is given through the Gift Aid Scheme. Gift Aid is reclaimed by St Peter's from the tax you pay for the current tax year. Your address is needed to identify you as a current UK taxpayer.
