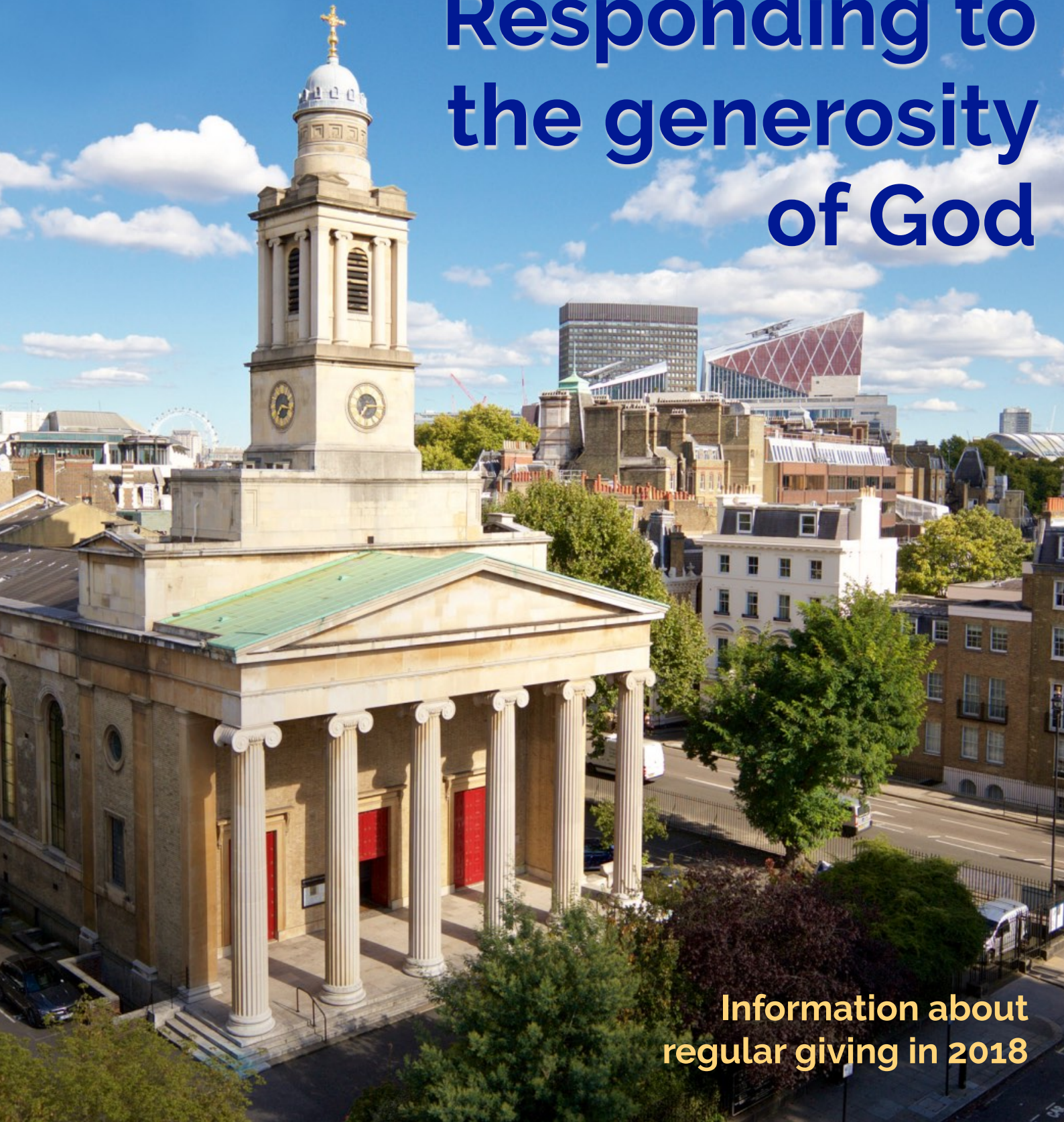

We work hard to build up our congregations, and to increase our work in the community, with children, young people and families, with all who are seeking God and life's meaning, with refugees and the homeless, to reach out with generosity to people in need.

## **Our costs are growing as we reach out**

Our beautiful church is used every day by a wide range of people, charities and organisations, but it costs over £1000 every day to run. Through careful stewardship we have income from car parking and the rental of the crypts, the Parish Hall and our other rooms. But the extra income we need to reach out to our community has to come from congregational giving, from each of us.

## **How can you help?**

You can help in two ways. Firstly, please bring your friends and neighbours to join us! The best way to increase our giving is to build up our congregation. Secondly, please take out a Standing Order to St Peter's, or increase the amount of money you give to support the church if you can. Our giving should be generous, whether we have a little or a lot. And if you do have a lot, remember there is no limit to the amount you can give!
